Reason for Request
 Alignment of ROI processes with proposed changes in NI; further Harmonisation; Minimising system changes for Suppliers; Ensuring change delivers real benefits.

Proposed Solution

There is currently a proposal in NI to introduce temperature corrected profiles in settlement. Whilst suppliers recognise that this will reduce the volume in the residual supplier unit we believe that further work is required to quantify the impact. It should now be possible to undertake this analysis in the Rol following the introduction of Global Aggregation in June this year. It is therefore proposed that the Data Aggregator undertake this analysis.

Subsequently if the analysis confirms the benefits it is proposed that temperature corrected profiling is introduced simultaneously in NI and Rol at a future date to be determined.
