Detail of Request
Reason for Request

This Discussion Request proposes that NIE will not adopt a cleansed address indicator process for Meter Point Address maintenance when a Change to Customer details market message 013 is received. The adoption of this process would have meant that once a cleansed address indicator had been set against a site then any subsequent Meter Point Address changes would have been rejected automatically. The Discussion Request therefore proposes to remove the cleansed address indicator and the automatic rejection of Meter Point Address changes on an 013. Instead, NIE will review all Meter Point Address change requests on an 013. Suppliers may still have Meter Point Address changes rejected but only after review by NIE. NIE retains the right to accept or reject any changes to the Meter Point address.

Proposed Solution

Remove the validation on 013 market message for NIE to mark a Meter Point Address as "cleansed" and to automatically reject.
