<b>Detail of Request</b>								
<b>Reason for Request</b>								
Currently Suppliers have no means of communicating to NIE that a de-energised site has been rewired prior to their request for re-energisation. This leads to fieldwork revisits - when the electrician goes on site to re-energise, they discover that the premise has been rewired and they are forced to reschedule the job as a connection card is required from the customer before NIE are allowed to re-energise the site.								
<b>Proposed Solution</b>								
This Discussion Request proposes that a new 'Meter Point Status Reason' code is added to the 017 market message. It is to allow Suppliers to notify NIE that a de-energised site, for which they are requesting re-energisation, has been rewired in the interim period. Adding the new Meter Point Status Reason (E04 - Re-energise (Rewire)) will notify NIE to wait until a valid Connection Card has been received from the customer before scheduling the re-energisation fieldwork. Suppliers will not be able to book appointments from the Market Website for these jobs.
