Proposed Solution
<p>The changes that have been applied to MPD 29 are as follows:</p> <p>Process Flow:</p> <ul style="list-style-type: none"> has been modified to include a Change of Supplier with and without a CoLE. Email templates have been included <p>Operations:</p> <ul style="list-style-type: none"> No Changes Please note, from an operational perspective, the Grouped UNM CoS will be processed by MRSO and the COLE will be processed by UMR. The Market Participant will deal with MRSO for the Grouped CoS part of the process and MRSO will communicate with UMR regarding the COLE (if there is a CoLE required or requested as part of CoS). If there are issues arising out of the COLE component that MRSO is unable to resolve with UMR, UMR will make contact with the relevant Market Participant. <p>It is important that MPs understand the correct process to follow where a new customer (COLE) wishes to change Supplier. It will progress as follows</p> <ul style="list-style-type: none"> New Customer contacts New MP requesting a CoS with a COLE. New MP sends 010 to MRSO (CoS processed first) MRSO sends request for change of legal entity to UMR (always happens after CoS has been processed) UMR processes the COLE. <p>Supplementary Information</p> <ul style="list-style-type: none"> The document has been updated with more information pertaining to Grouped CoS Process <p>Email Templates</p> <ul style="list-style-type: none"> Revised versions of the existing set of Grouped CoS email templates have been drawn up. Templates can be accessed on the RMDS website through the updated process flow as well as through menu system within the market design (under Other Documentation Unmetered Email Template) As per existing process, please can all MPs and MRSO ensure that they use these templates when communicating with each other. It facilitates easier communication and is less open to error and inaccuracy.
