Detail of Request
Reason for Request
<p>The RoI Retail Market currently uses ARIS, a Business Process Modelling tool, to display the Market Design (Market Process Diagrams, Market Messages, Market Segments and Codes and other documents relevant to the Market Design). In 2013 further to discussions with Market Participants and approval from CER, a decision was made to exit from ARIS. This aligns with the format in use by NIE and Gaslink.</p> <p>Due to the volume of MPDs and Market Messages to be converted multiple DR/MCRs are required. At the IGG on 28<sup>th</sup> March 2014 MCR 1145 was approved. The MCR covered 21 of the 41 MPDs and these are available on the RMDS website.</p> <p>This DR/MCR is intended to cover a further 9 MPDs and all 89 Market Messages. A further DR/MCR will be required for the balance of changes.</p>

Proposed Solution
<p>This solution will be delivered by generating MPD documents and Market Messages using Visio diagrams incorporated into MSWord documents. They will be generated into PDF format and published to the RMDS website for access by Market Participants. Market Messages will be drafted in Visio format as per their current structure in ARIS but generating the HTML from Visio and publishing to the web. These would drill down to Segments and Data Codes.</p> <p>This project will be delivered in stages and a new DR/MCR drafted for each stage. ARIS will continue to be updated until the project is finished or unless otherwise agreed by Market Participants and approved by CER.</p> <p>As these MPDs are being drafted and converted there are some corrections being identified – these are highlighted below and also recorded in the History of Changes for each MPD.</p> <p>Due to the volume of changes included in this DR it is not practical to embed all the MPDs and MMs in this DR/MCR document. All the related documents can, however, be found on the RMDS website using the link in red below. Please note this webpage is specific to this DR/MCR and cannot be viewed in isolation of this DR/MCR. This webpage</p>

containing the MPDs and MMs will remain as a permanent record of the contents of this DR/MCR.
