##### These definitions should be:

LP 7 - MD with LF up to (but not including) 30%  
 LP 8 - MD with LF greater than or equal to 30% but less than 50%  
 LP 9 - MD with LF greater than or equal to 50%

LF 1: <30%  
 LF 2 : 30% =<LF 2 <50%  
 LF 3: >= 50%
