Detail of Discussion Request
<p>Background:</p> <p>Market Participants requested the provision of a web service whereby a supplier could send out a procedural call to the ESB Networks MP Extranet website using an MPRN and pull back all of the data fields on the existing MPRN data screen on the MP Extranet website.</p> <p>A similar web service has already been developed for the contracting regulatory bodies (RECI) and is used as part of the process of advising receipt of a Completion Cert to ESB Networks. It appears that this web service cannot be re-used as it is not suitable for high volume usage and domestic customer names may also be displayed¹.</p> <p>Proposed Change:</p> <p>The new web service should contain all of the data fields on the existing MPRN Details screen tab on the MP Extranet (see Appendix 1) and the web service is also required to cater for high daily volume of procedural calls (perhaps up to 3000).</p>
