Reason for Request			
<p>It was originally agreed at harmonisation that NI Suppliers would use the appointment web-site to make a firm appointment booking for fieldwork (excluding New Connection and interval metered sites). On confirmation of the appointment booking an Appointment ID would be displayed on the web-site. The Appointment ID from the appointment web-site would then be included on the appropriate fieldwork or registration request message. If a valid fieldwork or registration request message had not been received from the Supplier within a specified time period after the appointment had been booked, a warning e-mail would be sent to the Supplier, and if no message was received after a further specified time period the appointment would be cancelled and MM 137R Appointment Rejection message would be sent to the Supplier.</p> <p>In RoI Suppliers use the appointment web-site to view available appointment slots and then include an Appointment Date and Appointment Time Slot on the appropriate fieldwork request market message in order to request an appointment. If the requested appointment is not available when the message is received by ESB a 137R Appointment Rejection market message is sent to the Supplier.</p>			
Proposed Solution			
<p>Northern Ireland Suppliers will use the appointment web-site to view available appointment slots and then include an Appointment Date and Appointment Time Slot on the appropriate fieldwork or registration request market message in order to request an appointment. This will apply to the following market messages:</p> <p>010 - Registration Request (Change of Supplier) 017 - Meter Point Status Change Request 030 - Meter Works Request 252 - Special Read Request</p> <p>If the requested appointment is not available when the message is received by NIE, MM 137R Appointment Rejection message will be sent to the Supplier. The fieldwork or registration request will not be rejected if the requested appointment is not available.</p> <p>On receipt of MM 137R it will be the responsibility of the Supplier to re-arrange an appointment. The Supplier will be able to use the appointment web-site to request available appointments, select one of these and book a firm appointment.
