Detail of Request

Reason for Request

Two of the Downloadable Meter Point files display technically installed meters as well as billable ones. This means that if Suppliers use these files to validate the information received at CoS, or following a meter change, it cannot be immediately reconciled with the information received on the Market Message (320 or 332 etc). This was also the case with the Retail Market Participant Extranet website until the implementation of MCR 0081 (attached) in November 2010, which amended the display to only show billable meters. This DR is to request that the Downloadable Meter Point files should only display billable meters.
Please also refer to MCR 179 (attached) for background on the Downloadable Meter Point Files design.

Proposed Solution

The Downloadable Meter Points Files should be amended to show billable meters only, in order to keep it in line with the Retail Market Participant Extranet website. There are five files in the suite of Downloadable Meter Point Files. They are

1. Domestic MPRN Details (domS_CUST.csv) ;
2. Domestic Meter Details (dom_reg.csv) ;
3. Commercial MPRN Details (COMM_CUST.csv);
4. Commercial Meter Details (COM_REG.csv)
5. Unmetered MPRN Details (unmt_cust.csv).

Two of these files will be effected by the proposed change. They are:-

4. Commercial Meter Details (COM_REG.csv).
