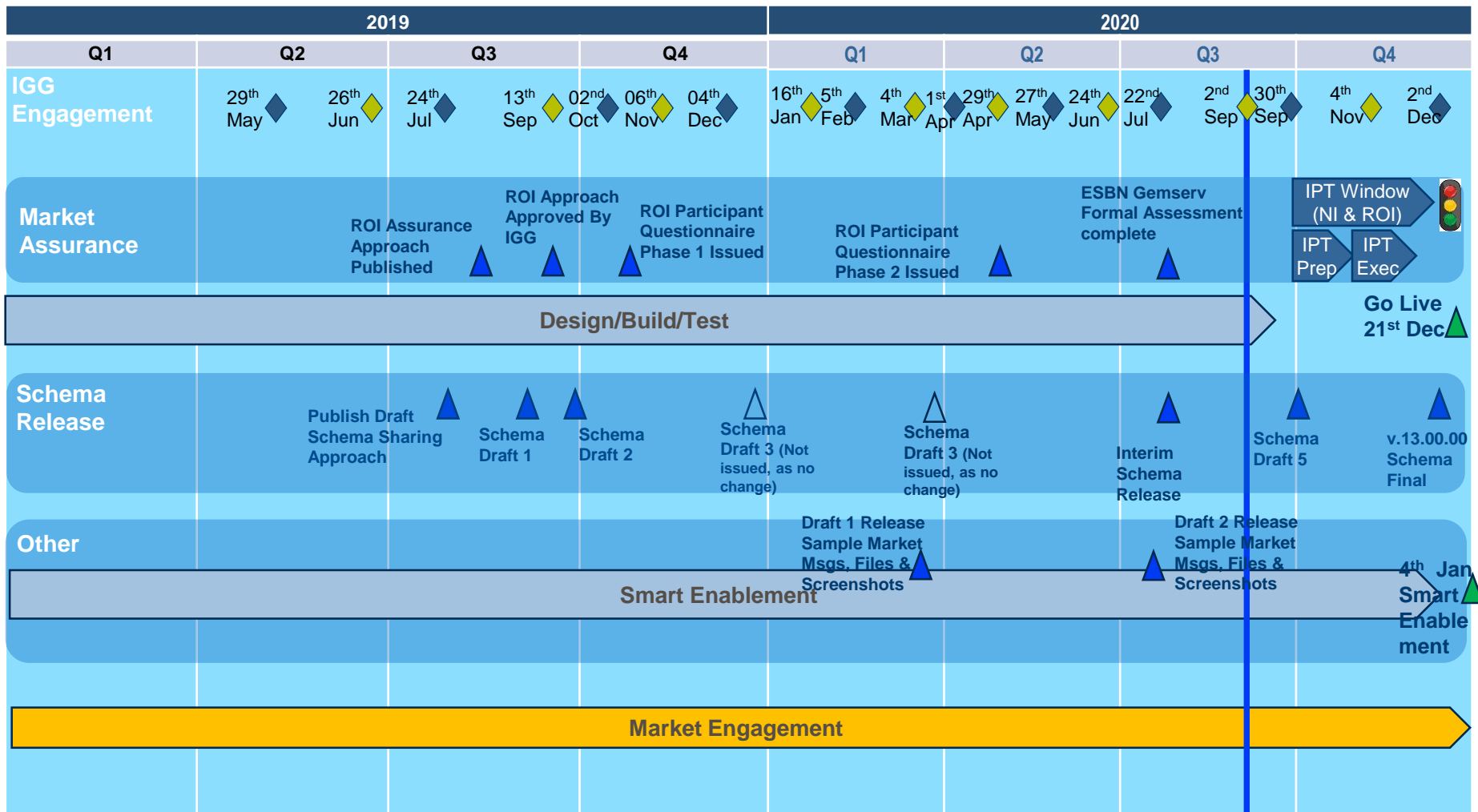

Change Summary	<p>In relation to the National Smart Metering Programme, the CRU wishes to increase the default level of data granularity for all customers with smart meters and would like to discuss alternatives to implement this change.</p> <p>Two options are presented for delivery of DR1208.                      The first utilises the V.13 processes, requires no schema changes, is available from January 2021 and allows each Supplier to initiate the MCC16 change for their customers. Irrespective of whether the customer has elected to be on a Standard Smart Tariff the Supplier may request the change to MCC16.                      The second option would process the SST data via a non-market “data repository” and would require a number of changes across the AMI (meter firmware, HES and MDMS), as well as development of the data repository and the protocols for data access.</p>

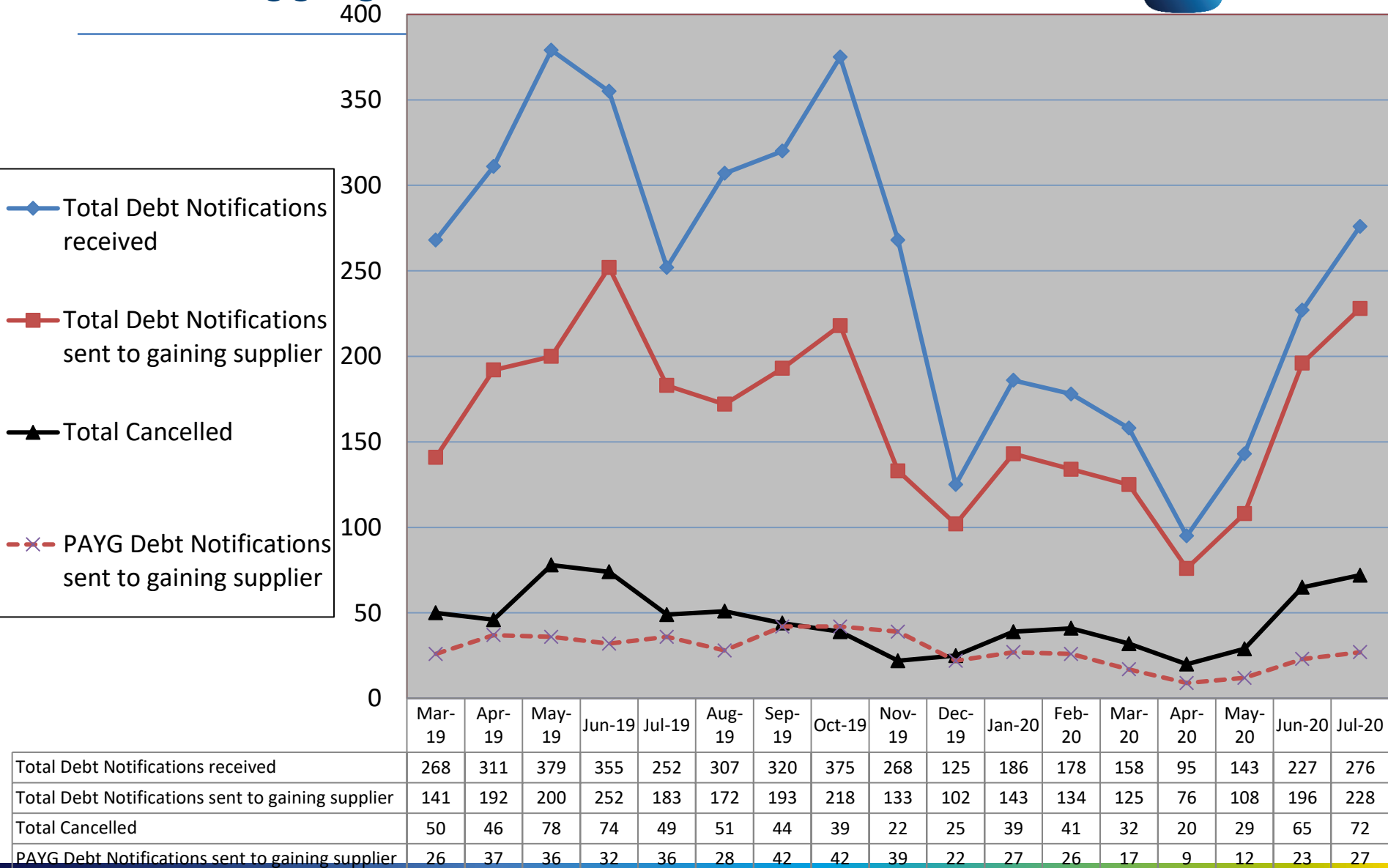

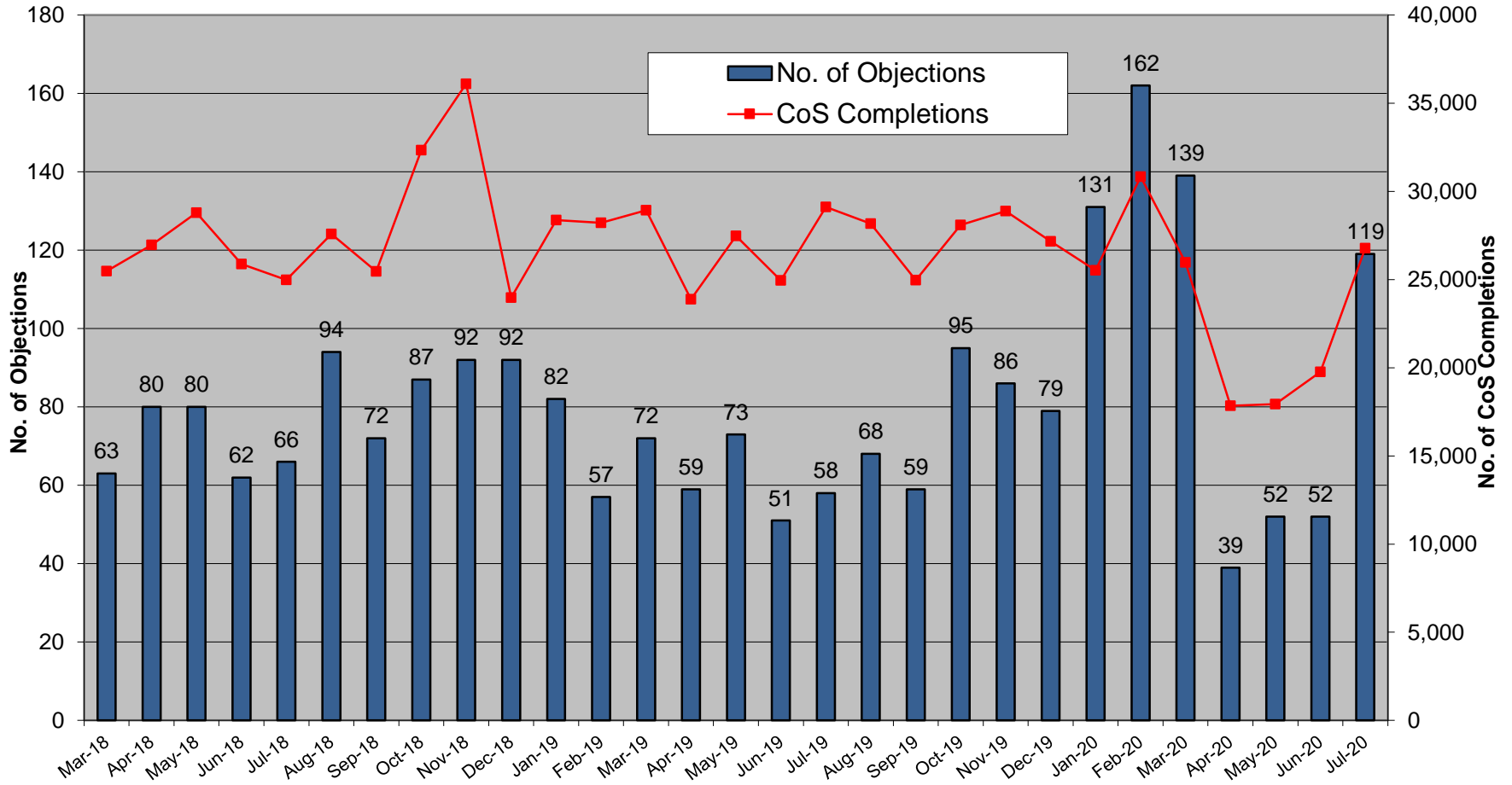

# Comms Technically Feasible (CTF)

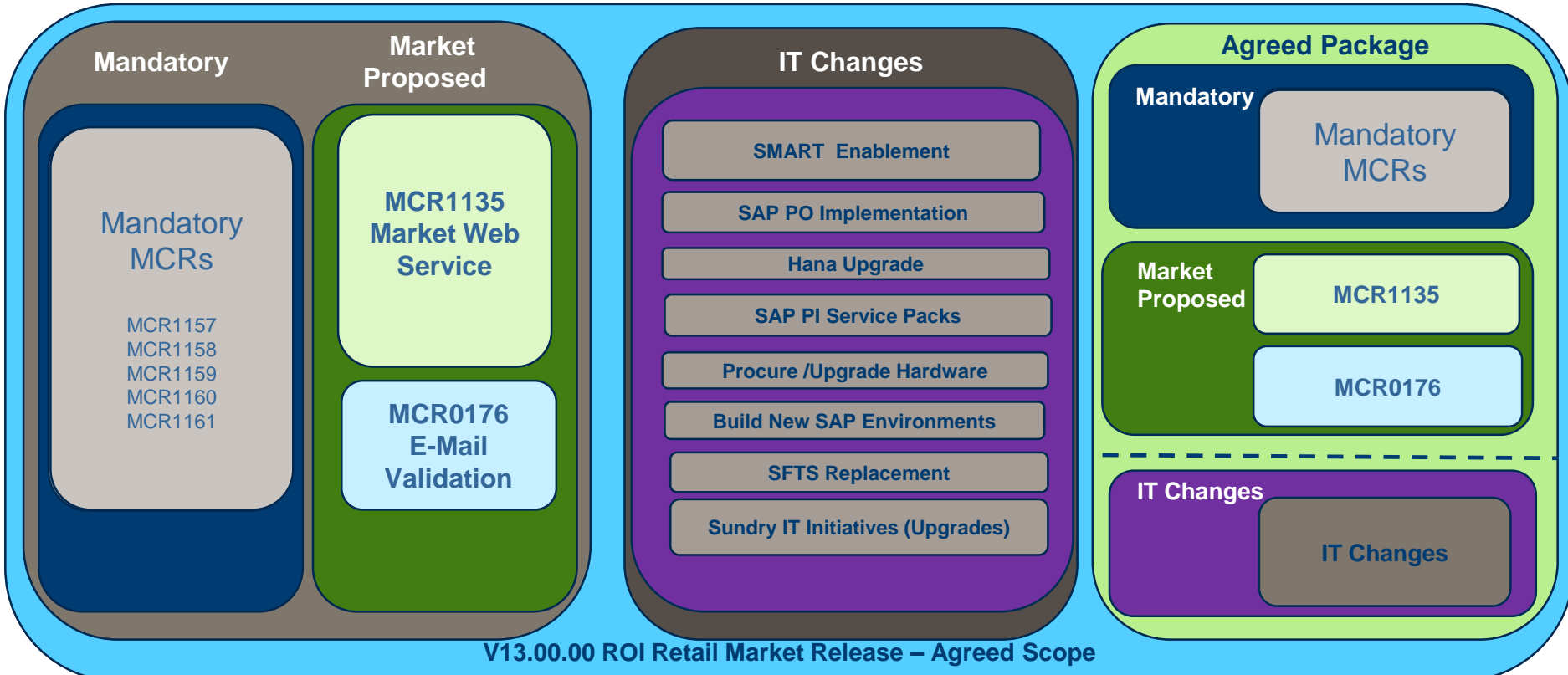


- As per the v13.00.00 Cutover Approach communicated on 10<sup>th</sup> July 2020 via ReMCoDS, ESBN will be providing an MPRN level CTF file to Market Participants as part of cutover. This will be a .csv file containing a list of MPRNs with Smart Meters that have completed the Comms Proving Period, and the CTF value for each MPRN.
- A single file will be generated and issued to all Market Participants on 31<sup>st</sup> December 2020 via a dedicated Email Distribution list, once the Smart Meter Data Sync has completed and scheduled Meter Reading Orders have been issued for that day.
- Market Participants are requested to sign up to the Email Distribution list via RMDS in advance of Cutover commencing on Friday 18<sup>th</sup> December in order to receive the list of MPRN's
- Please note the following:
  - By signing up to the Email Distribution List you are consenting for RMDS to send you the List of MPRNs.
  - This is a once off file as CTF values will be available on the RMP Extranet, Downloadable Files and MPRN Enquiry Web Service from Monday 4<sup>th</sup> January 2021.

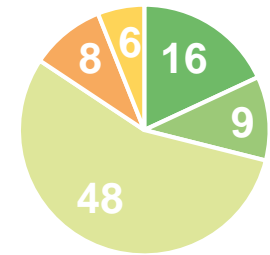

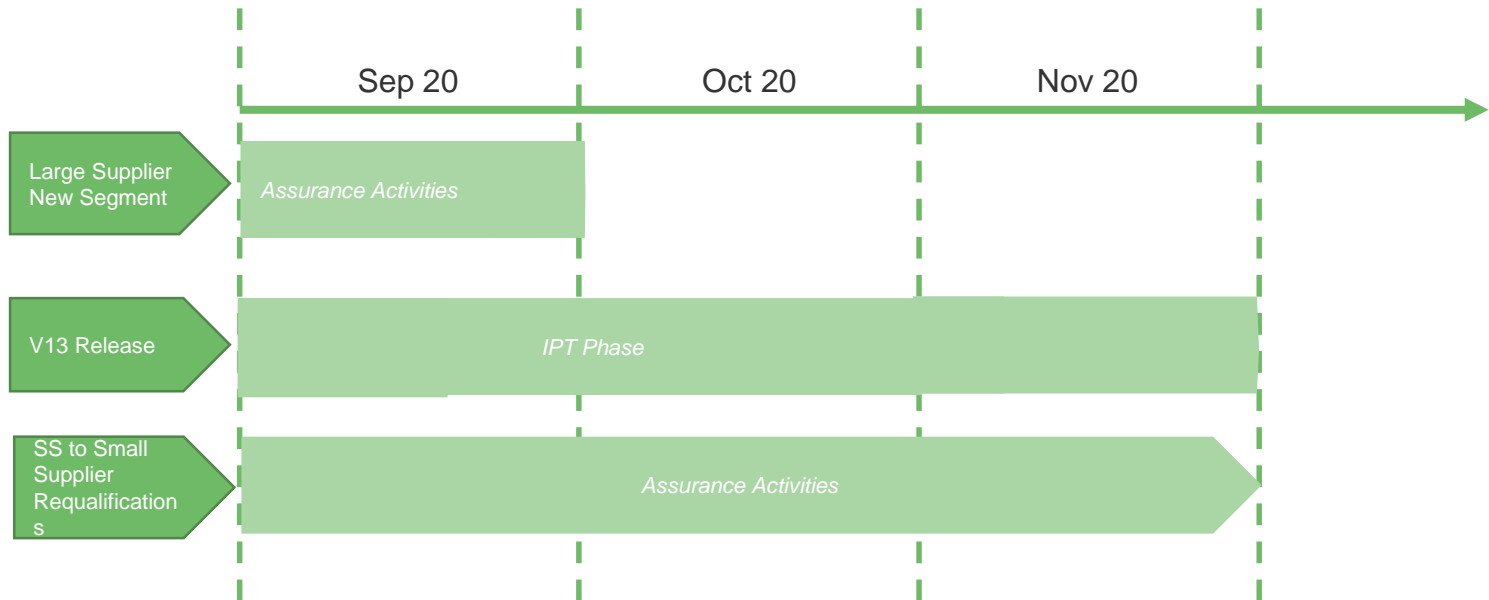

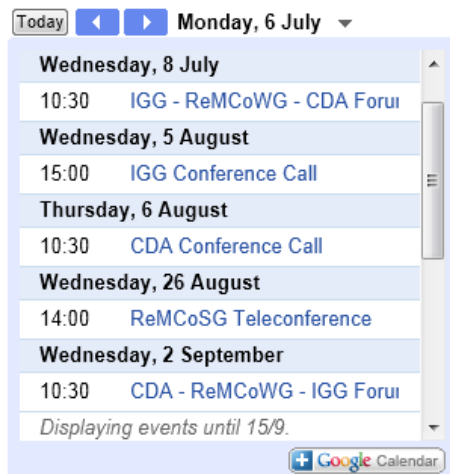
